In the case of representation of body corporate and corporation, the Postal Ballot must be accompanied by the required document subject to the provision of Section(s) 138 or 139 of the Companies Act 2017, unless already submitted with the Proxy Form. For foreign entities, all documents must be attested by the relevant Pakistani Embassy.
